LIS PENDENNOICE

Comes Now, Medical Supply Chain, Inc. by its president and chief executive officer Samuel Lipari and makes the present notice of litigation pending in the actions Medical Supply Chain, Inc. v. General Electric et al Case No's 04-3072 and 04-3102 before the Tenth Circuit Federal States Court of Appeals, Denver Colorado concerning Leasehold and contents:
